Approve the Acquisition of Right-of-Way #7077-E (4800 Street Road LLC), a partial take parcel necessary for construction of the I-95A, Ramp D project, by authorizing payment of \$275,476.07 representing fair market value, pro-rated taxes and recording fees to Diversified Settlement Services, Inc., as escrow agent; authorize the appropriate Commission officials to execute the agreement of sale and other documents that may be required for closing, authorize the payment of additional statutory damages as calculated by the Right-of-Way Administrator and approved by the Chief Counsel; and payment of fair market value to the property owner is contingent upon the delivery of a deed as prepared by the Legal Department.
- 4. Approve advertising for Open-end Construction Technical and Management Services systemwide.
- 5. Approve the Award of a Bid and the Issuance of Purchase Orders for the items listed in memos "a" through "e":
  - a. Open-end drilling contract-East, to the lowest responsive and responsible bidder, TRC
     Engineers, Inc.; at a total not-to-exceed amount of \$900,000.00 or three (3) years, whichever occurs first;
